

DATA PROCESSING NOTICE REGARDING THE PROCESSING AND PROTECTION OF PERSONAL DATA OF PARTICIPANTS IN COMPETITIONS AND SIMILAR EVENTS

As Invent Yazılım Danışmanlık A.Ş. (hereinafter referred to as “**INVENT**” or “**the Company**”), located at “Reşitpaşa Mahallesi Katar Caddesi No:4/1/302 Sarıyer/İstanbul”; your personal data in the form of identity information, contact information, residence address, school information, e-mail address, and bank account information in case of ranking is processed solely for the following purposes:

- To maintain communication regarding developments and results throughout the duration of the event,
- To take precautions regarding any potential irregularities that may arise at the Company hosting the event and the facility,
- To maintain Human Resources strategies by keeping participant records,

The personal data referred to above will be transferred to the managers and personnel of INVENT’s human resources department, to Company executives if deemed necessary, to the facility hosting the event (TEKNOKENT), and to Microsoft Corporation, Amazon Web Services, and Google, with whom we have a business relationship for the purpose of operating information systems in accordance with the Law and Article 9. Additionally, it will be transferred to our foreign subsidiary, Invent Analytics LLC. Your personal data is collected, for the purposes referred to above, based on the legal grounds specified in Article 5(2)(d), (e), (f) and Article 6 (3), (4) of Law No. 6698 on the Protection of Personal Data (“Law”); when it has been publicly disclosed by the data subject himself/herself, when data processing is necessary for the establishment, exercise, or protection of a right, and when data processing is mandatory for the legitimate interests of the Company, provided that it does not adversely affect the fundamental rights and freedoms of the data subject.

You may request to exercise your rights;

- To obtain information on whether your personal data is being processed,
- To request information if your personal data has been processed,
- To learn the purpose of processing your personal data and whether your data is used in accordance with its purpose,
- To have knowledge of the third parties to whom your personal data is transferred domestically or abroad,
- To request correction of your personal data in case of incomplete or incorrect processing,
- To request the deletion or removal of personal data within the framework of the conditions foreseen in Article 7 of the Law,
- To request notification of the transactions carried out pursuant to Article 11(d) and (e) of the Law to third parties to whom your personal data has been transferred,
- To object to the occurrence of a result against you through the analysis of your processed data exclusively by automated systems.
- To request compensation for damages in the event that you suffer damage due to unlawful processing of your personal data

by contacting INVENT at any time.

To submit your requests regarding your rights and the application of the Law, you may fill out the application form available at www.inventanalytics.com and send it with your wet signature to the address 'Reşitpaşa Mahallesi Katar Caddesi No:4/1/302 Sarıyer/Istanbul' via notary, registered mail with return receipt, or in person. Alternatively, you may send the application form filled out electronically after signing it with your mobile signature or secure electronic signature to invent@hs03.kep.tr or info@inventanalytics.com, using your KEP (Registered Electronic Mail, REM) address or the email address currently registered in the Company's data recording system. INVENT will respond to requests within this scope in writing without charging a fee for up to ten pages; for each page exceeding ten pages, a service fee of 1 Turkish Lira will be charged. If the response to the application is provided on a recording medium such as a CD or flash drive, the fee requested by the Company shall not exceed the cost of the recording medium.
